

DRAINAGE DISTRICT MINUTES
JOINT DISTRICT HARDIN #35-STORY #1
MAY 5, 2020

The Story County Drainage District Trustees met in the Public Meeting Room of the Story County Administration Building in Nevada, IA to consider a levy (attached) against Joint Drainage District Hardin #35-Story #1, Hardin County controlling. Members present were Linda Murken, chair, Lisa Heddens, and Lauris Olson. Also present was Drainage Clerk Scott Wall.

Murken called the meeting to order at 9:30 a.m. and stated that, due to the ongoing OVID-19 pandemic, public access to the meeting was by telephone only.


Heddens asked Wall if he could provide any details concerning the proposed levy.

Wall said, since the last levy in 2017, there had been a tile repair in Hardin County and extensive tree removal by Story County IRVM on the Story County side of the district which had depleted district funds. As the work was all typical maintenance the trustees do not need to hold a joint meeting but can approve the levy separately. The Hardin County Trustees approved this levy on April 28, 2020.

Heddens moved, seconded by Olson, to approve a levy of 27.302% against Joint Drainage District Hardin #35-Story #1, said levy to be dated May 5, 2020 with assessments to be due and payable on or before September 30, 2020. Motion carried unanimously (MCU).

Olson moved, seconded by Heddens, to adjourn. MCU. Meeting adjourned at 9:33 a.m.




