Narrative

ON MAY 13TH, 2014 I WAS DISPATCHED TO THE AREA OF 580TH AVE AND 220TH ST. FOR A SINGLE VEHICLE ROLL OVER WITH POSSIBLE INJURY.

THE DRIVER OF VEHICLE ONE WAS TRAVELING EAST ON 220TH ST. AT APPROXIMATELY 45 MPH AND LOST CONTROL OF THE VEHICLE CAUSING HER TO ENTER THE SOUTH DITCH AND ROLLING ONTO IT'S TOP. THE DRIVER WAS TRANSPORTED TO STORY COUNTY HOSPITAL WITH POSSIBLE INJURIES. BUTCH'S TOWED THE VEHICLE. THE DRIVER WAS WEARING HER SEATBELT, NO AIRBAGS WERE DEPLOYED. THIS HAPPENED ON A GRAVEL ROAD WITH FRESH (LOOSE) GRAVEL.
