Stabilized sludge is applied to local land according to state regulations.

Anyone wishing to comment on or object to the proposed issuance of this permit must do so in writing within forty-five (45) days of the date shown at the top of this notice. All comments received will be considered in the final determination. If no objections are received within forty-five (45) days, the Department will issue a final permit. You may request the Department hold a public hearing by submitting a written request stating specific reasons why a hearing should be held.

PUBLIC NOTICE PROCEDURES AND CERTIFICATION

Enclosed are three (3) copies of a public notice prepared by the Department stating our proposal to REISSUE an NPDES permit. In addition to the distribution of this notice already made by the Department, you are required by the Iowa Administrative Code to circulate the public notice in the following manner:

1. Post a copy of the public notice in a public place, such as the post office, library, city hall and/or other public places within the city.
2. Post the public notice at your facility or your facility offices.
3. Publish the public notice in the local newspapers for one day AT YOUR OWN EXPENSE.

You must publish and post the notice no later than 15 days from the "Notice Date" shown on the enclosed notice. The posted notices must remain in place for thirty (30) days.

The notice that you publish must contain all of the information shown on the attached page titled "National Pollutant Discharge Elimination System".
