SHALL THE FOLLOWING PUBLIC MEASURE BE ADOPTED?

The Board of Directors of the Colo-Nesco Community School District in the Counties of Story, Hardin and Marshall, State of Iowa, does hereby resolve to participate in the Instructional Support Program for a period of ten (10) years, to levy annually, as determined by the Board, an instructional support property tax which will be levied annually upon the taxable property within the District, commencing with the levy of property taxes for collection in the fiscal year ending June 30, 2003, and an instructional support income surtax imposed annually for each budget year, the percent of income surtax (not to exceed twenty percent (20%)) to be determined annually by the Board for each budget year to be imposed upon the state individual income tax of each individual income taxpayer resident in the District on December 31, 2002, and each year thereafter.

The funds thus collected, when combined with Instructional Support State Aid shall not exceed ten percent (10%) of the regular program district cost, including the budget adjustment for any budget year. (Iowa Code 257.14). Instructional Support Program funds may only be used to pay for textbooks, instructional materials, equipment (including technology), and classroom furniture.
