The following request is made to get ASSET Volunteer Linda Hagedorn's term's beginning and ending dates consistent with other ASSET appointments:

- Accept Linda Hagedorn's resignation of her appointment to ASSET, effective 3/31/23
- Immediately reappoint Linda Hagedorn to begin her second term (4/5/23 – 3/31/26)

The above request is made to avoid having volunteers' terms terminate at the end of a calendar year. For volunteers, ASSET's budget allocation work can begin in December and get very busy in January, which is our busiest month.
