

DRAINAGE MEETING
JOINT DISTRICT BOONE #140-STORY #7
JUNE 18, 2025

The Drainage District Trustees of Boone and Story Counties met via Zoom in the Public Meeting Room of the Story County Administration Building, Nevada, IA to consider a request (on file in the Boone and Story County Auditor's Offices) to re-route a drainage district tile in Joint Drainage District Boone #140-Story #7, Boone County controlling. Members present were Shawn Bryant, chair, Erich Kretzinger, and Scott Longhorn of Boone County and Linda Murken and Latifah Faisal of Story County. Also present were Boone County Board Secretary Julie Hinman and Drainage Clerk Kaitlynn Moran and Story County Communications Assistant Bryce Garman and Drainage Clerk Scott Wall.

Bryant called the meeting to order at 10:00 a.m.

Murken moved, seconded by Kretzinger, to approve the agenda. Motion carried unanimously (MCU).

Moran said the request is to relocate a district tile that runs across a lot in a new subdivision in Story County so the lot can be developed. Drainage Engineer Tyler Conley from Bolton and Menk has reviewed the plan for the re-routing and stated that he has no issues with the proposal.


Faisal asked who would pay for the re-routing.

Jonathon,

I am working on a small two lot platted subdivision on the east side of Story County 500th Ave. in Slater for Craig and Julie Weeks. There is an existing 8" lateral drainage tile that passes through the center of one of our proposed lots. Although we are located in Story County, the tile is part of a Boone County Drainage District #7. We are proposing to re-route the tile around the lot in a drainage easement and re-connect into the existing 30" County trunk tile. The existing tile will be abandoned in place and cap at the upper end and just outside the connection to the 30" trunk main.
