

The Board of Supervisors met on 9/19/23, at 9:00 a.m. in the Public Meeting Room at the Story County Administration as the Board of Canvassers for the Ballard Community School District (CSD) Special Election, held on 9/12/23. Present were Latifah Faisal, and Lisa Heddens, with Chairperson Faisal presiding and Heddens via Zoom.

Heddens moved, Faisal seconded to approve the agenda. Motion carried unanimously on a roll call vote. (MCU)

Lucy Martin, Auditor and Commissioner of Elections, reported the special election was for a Revenue Purpose Statement. There were two (2) provisional ballots cast; both were accepted for counting. Voter turnout was 5.61% and greater than expected based on past special elections of this type. She thanked her staff, the election officials, and Facilities Management and Information Technology. Martin noted the upcoming City-School election on November 7, 2023. The candidate filing deadline is this week. Heddens asked about polling locations and Martin explained four vote centers were used. Heddens moved, Faisal seconded the approval of Resolution #24-23. Roll call vote. (MCU)

Faisal moved, Heddens seconded to declare the canvass complete and certify the results of the election to the appropriate jurisdiction. Roll call vote. (MCU)

Heddens moved, Faisal seconded to adjourn at 9:05 a.m. Roll call vote. (MCU)



Three hundred and fifty-two (352) people voted at the polls on election day.

 Two (2) provisional ballots were accepted for counting (subset of absentee total).
 A total of three hundred and fifty-six (356) people voted.


