

The Board of Supervisors met on 4/2/24, at 9:00 a.m. in the Public Meeting Room at the Story County Administration as the Board of Canvassers for the City of Huxley Special Election, held on 3/26/24. Present were Lisa Heddens, Linda Murken, and Latifah Faisal, with Chairperson Heddens presiding. (all audio of meetings available at storycountyiowa.gov; any resolution is effective upon signature and can be inspected M-F, 8-4:30, at 900 6th Street, Nevada, Iowa)

Lucy Martin, Auditor and Commissioner of Elections, reported the special election was for the City of Huxley to fill two vacant seats on its city council. One (1) provisional ballot was accepted for counting. Turnout for the election was 7.5%; Martin compared it to the 20% turnout in Huxley at the most recent City Election last November. Martin thanked Kevin Norris, Deputy Auditor of Elections, permanent and temporary staff, Facilities Management, and Information Technology. She provided information regarding the upcoming Primary Election, and stated information is available on the County's website. Voting commences on 5/15/24. Deputy Auditor Kevin Norris thanked the support staff and stated it was an uneventful election. Martin stated the post-election audit yesterday was perfect.

Faisal moved, Murken seconded the approval of Resolution #24-67. Roll call vote. (MCU)

Murken moved, Faisal seconded to declare the canvass complete and certify the results of the election to the appropriate jurisdiction. Roll call vote. (MCU)

Faisal moved, Murken seconded to adjourn at 9:04 a.m. Roll call vote. (MCU)

WHEREAS, a SPECIAL ELECTION was held for the City of Huxley as prescribed by law on March 26, 2024, and




