

The Board of Supervisors met as the Board of Canvassers on 6/11/24, at 11:30 a.m. in the Public Meeting Room of the Story County Administration to certify the results of the Primary Election held on 6/4/24. Lisa Heddens and Linda Murken, with Heddens presiding. Latifah Faisal absent.

Lucy Martin, Auditor, reported the Primary Election is a nomination process for the recognized parties in Iowa to choose candidates for the General Election in November. Voter turnout was just under 5.5%. Martin thanked her management team of Kevin Norris, Lisa Markley and Rhonda Sykes, her employees, and temporary staff. She also thanked her vendor, Adkins, for onsite support, as well as Facilities Management, Information Technology, the Sheriff's Office, Emergency Management, and the Board. She reported six (6) provisional ballots were cast in the election: four (4) were accepted and two (2) were rejected. Martin thanked the Absentee Board for its work on the post-election audit and the administrative recount as well as its regular duties. Murken moved, Heddens seconded the approval of Resolution #24-86. Motion carried unanimously (MCU) on a roll call vote.

County Auditor: Lucy Martin, Democratic Party

County Sheriff: Paul H. Fitzgerald, Democratic Party

Republican Party: Board of Supervisors; County Auditor; County Sheriff

Murken moved, Heddens seconded to declare the canvass complete and certify the results of the election to the proper parties and jurisdictions (on file in the Auditor's office). Roll call vote. (MCU)

RESOLUTION #24-86 – CERTIFICATION (CANVASS) OF PRIMARY ELECTION RESULTS

WHEREAS, the PRIMARY ELECTION was held as prescribed by law on June 4, 2024, and;

WHEREAS, the Board of Supervisors and *ex officio* Board of Canvassers have canvassed the vote of said election in accordance with §43.49 and §50.24 of the *Code of Iowa*, now therefore;

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and *ex officio* Board of Canvassers of Story County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the PRIMARY ELECTION, held June 4, 2024, and that no obvious clerical errors were identified during the canvass.

Three thousand three hundred and forty-four (3,344) people voted at the polls on election day.
Four hundred and eighty-one (481) absentee ballots were accepted for counting.
Four (4) provisional ballots were accepted for counting (included in absentee total).
A total of three thousand eight hundred and twenty-five (3,825) people voted.




