

The Board of Supervisors met on 11/19/24, at 9:00 a.m. in the Board Room at the Story County Administration as the Board of Canvassers for the Second-Tier Canvass for Slater General Obligation Bond Special Election, held on 11/5/24. Present were Lisa Heddens and Linda Murken, with Heddens presiding. Latifah Faisal absent. Auditor Lucy Martin reported the second-tier canvass certifies the election results for jurisdictions in more than one county; she again thanked her staff and precinct election workers. Deputy Auditor Kevin Norris stated no votes were cast in Boone County so the numbers are the same as those for the first-tier canvass. Murken moved, Heddens seconded approving the Resolution #25-38, Certification of Multi-Jurisdiction Election Results for the 11/5/24 Election. Motion carried unanimously (MCU) on a roll call vote. Heddens moved, Murken seconded to declare the canvass complete and certify the results of the election to the appropriate jurisdictions. Roll call vote. (MCU).
