Lucy Martin, Auditor and Commissioner of Elections, reported that no (0) provisional ballots were cast in this election. Voter turnout was just over 13%. It was a special election, petitioned by the citizens of the City of Nevada, to fill vacancies. Martin thanked her staff and the poll workers.
