

The Board of Supervisors met on 10/21/25 at 10:00 a.m. in the Story County Administration Building. Lisa Heddens, Linda Murken, and Latifah Faisal, with Heddens presiding. (all audio of meetings available at [storycountyiowa.gov](http://storycountyiowa.gov)); any resolution is effective upon signature and can be inspected during business hours, Monday-Friday, 8-4:30, at 900 6<sup>th</sup> Street, Nevada, Iowa)

**ADOPTION OF AGENDA:** Murken moved, Faisal seconded adopting the agenda as listed. Motion carried unanimously (MCU) on a roll call vote.

**PROCLAMATION RECOGNIZING 10/28/25 AS NATIONAL FIRST RESPONDERS' DAY:** The Board read the Proclamation in full. Heddens moved, Faisal seconded the approval of the Proclamation recognizing 10/28/25 as National First Responders' Day. Roll call vote. (MCU)

**AMES REGIONAL ECONOMIC ALLIANCE DEVELOPMENT OUTREACH QUARTERLY REPORT:** Brenda Dryer, Senior Vice President, reported on rural community outreach, commercial development in Gilbert, and housing subdivisions in Roland, Maxwell, and Colo. She provided real estate statistics. Discussion took place.

**RESOLUTION #26-28 SETTING DATE AND TIME OF 11/18/25 AT 10 A.M. FOR A PUBLIC HEARING ON AMENDMENT TO THE URBAN RENEWAL PLAN FOR THE STORY COUNTY URBAN RENEWAL AREA (URA):**

Heddens read a statement that an amendment to the Urban Renewal Plan for the Story County Urban Renewal Area had been prepared, and that it was now necessary to set a date for a public hearing on the proposed amendment. Leanne Harter, Planning and Development Director, reported on the amendment process. The amendment is necessary if the County wants to include tax increment financing (TIF) support for the Story County Housing Trust to assist housing projects for low- and moderate-income family housing. If the resolution is adopted, the public hearing is scheduled for 11/18/25 with a consultation meeting with impacted tax entities to be held on 11/4/25. Murken stated, for the record, her concerns: 1) the current plan lacks certain specifics which may not be available given the timeline for certifying TIF debt for the upcoming fiscal year; 2) the availability and amount of non-TIF funds needed for legal administrative fees; 3) the open question of whether or not the Story County Housing Trust will have an administrative fee and whether or not it could be funded with TIF dollars; and, 4) due to timing issues, potentially collecting TIF funding for a plan that does not materialize and then having to apportion it back to the taxing entities if it is not used. Murken stated she wants to support the amendment but is currently lacking answers to several questions. Discussion took place. At Murken's request, Auditor Lucy Martin provided remarks. She stated her concerns were broader, based on the stated intent of the Legislature and the Governor to further amend property tax law coupled with the current and possible additional restrictions on property tax growth as well as Iowa's dismal revenue estimates for both the current fiscal year and the next one. TIF debt is debt, and all taxing authorities that utilize TIF will be responsible for the debt regardless of any changes to TIF law. Additional discussion took place. Harter reiterated the timeline and meeting dates for the amendment. Additional discussion took place. Faisal moved, Murken seconded approving Resolution #26-28, Setting Date of 11/18/25 at 10 a.m. for a Public on Amendment to the Urban Renewal Plan for the Story County Urban Renewal Area. Roll call vote. (MCU)

**ANIMAL CONTROL QUARTERLY REPORT:** Director Anna Henderson reported on the increase in intakes, adoption statistics, animal control calls, volunteers, recognition as a no-kill shelter, outreach efforts, donation drives, and clinic with Iowa State University Veterinary Medicine School.

**STORY COUNTY QUARTERLY FINANCIAL REPORT:** Lisa Markley, Assistant Auditor, reported on the overall financial condition, and provided details on fund balances, federal dollars, and expenditures.

**SUMMIT CARBON SOLUTIONS PROJECT UPDATE:** Joseph Crosgrove, Project Manager, reported on new leadership, the company's landowner and community partnership program, and the scheduled public information sessions in November. He answered some clarifying questions from the Board.

**LIAISON ASSIGNMENTS, COMMITTEE MEETINGS UPDATES, AND ANNOUNCEMENTS FROM THE SUPERVISORS:** All Board members reported on multiple items.

**CLOSED SESSION PURSUANT TO CODE OF IOWA §21.5(1)(c):** Murken moved, Faisal seconded to go into closed session at 10:57 a.m. Faisal aye, Murken aye, Heddens aye. Motion carries.

Heddens reconvened the Board in open session at 11:23 a.m.

### Gilbert LTD Development

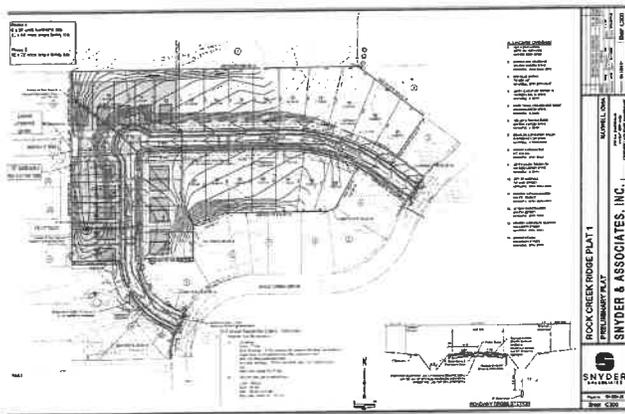

The Colo Telephone Company, incorporated under the laws of Iowa, with its principal place of business at 303 Main St Colo IA, does hereby make application requesting permission to occupy certain portions of public right-of-way and that the County Engineer be directed to establish the location of lines of transmission of fiber optics on secondary route 667th Ave, from 23436 667th Ave to 23514 667th Ave, a distance of 0.172 miles.

Agreements: The utility company, corporation, applicant, permittee, or licensee, (hereinafter referred to as the permittee) agrees that the following stipulations shall govern under this permit.

1. The Permittee will file a plat setting out the location of proposed line on the secondary route and that the description of the proposed installation including type, height, and spacing of poles, maximum voltage, lengths of cross arms, minimum clearance and number of wires, type, size and capacity of underground cables, conduits, tile lines, and pipe lines, maximum working pressures for pipe lines carrying gas or flammable petroleum products are described as follows:
2. The installation shall meet the requirements of county, state, and federal laws, franchise rules, and of the Iowa State Commerce Commission Regulations and Directives, Utilities Division, the Iowa State Department of Health, and any other laws or regulations applicable.
3. The Permittee shall be fully responsible for any future adjustments of its facilities within the established highway right-of-way caused by highway construction or maintenance operations.
4. Story County assumes no responsibility for damages to the Permittee's property occasioned by any construction or maintenance operations on said highways.
5. The Permittee shall take all reasonable precautions during the construction and maintenance of said installation to protect and safeguard the lives and property of the traveling public and adjacent property owners.
6. The Permittee, and its contractors, shall carry on the construction or repair of the accommodated utility with serious regard to the safety of the public. Traffic protection shall be in accordance with Part VI of the current Iowa Department of Transportation Manual on Uniform Control Devices for Streets and Highways.
7. The Permittee shall be responsible for any damage resulting to said highways because of the construction operation, or maintenance of said utility, and shall reimburse Story County for any expenditure the County may have to make on said highways because of said permittee's utility having been constructed, operated, and maintained thereon.

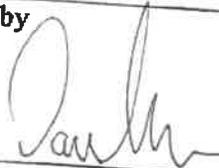

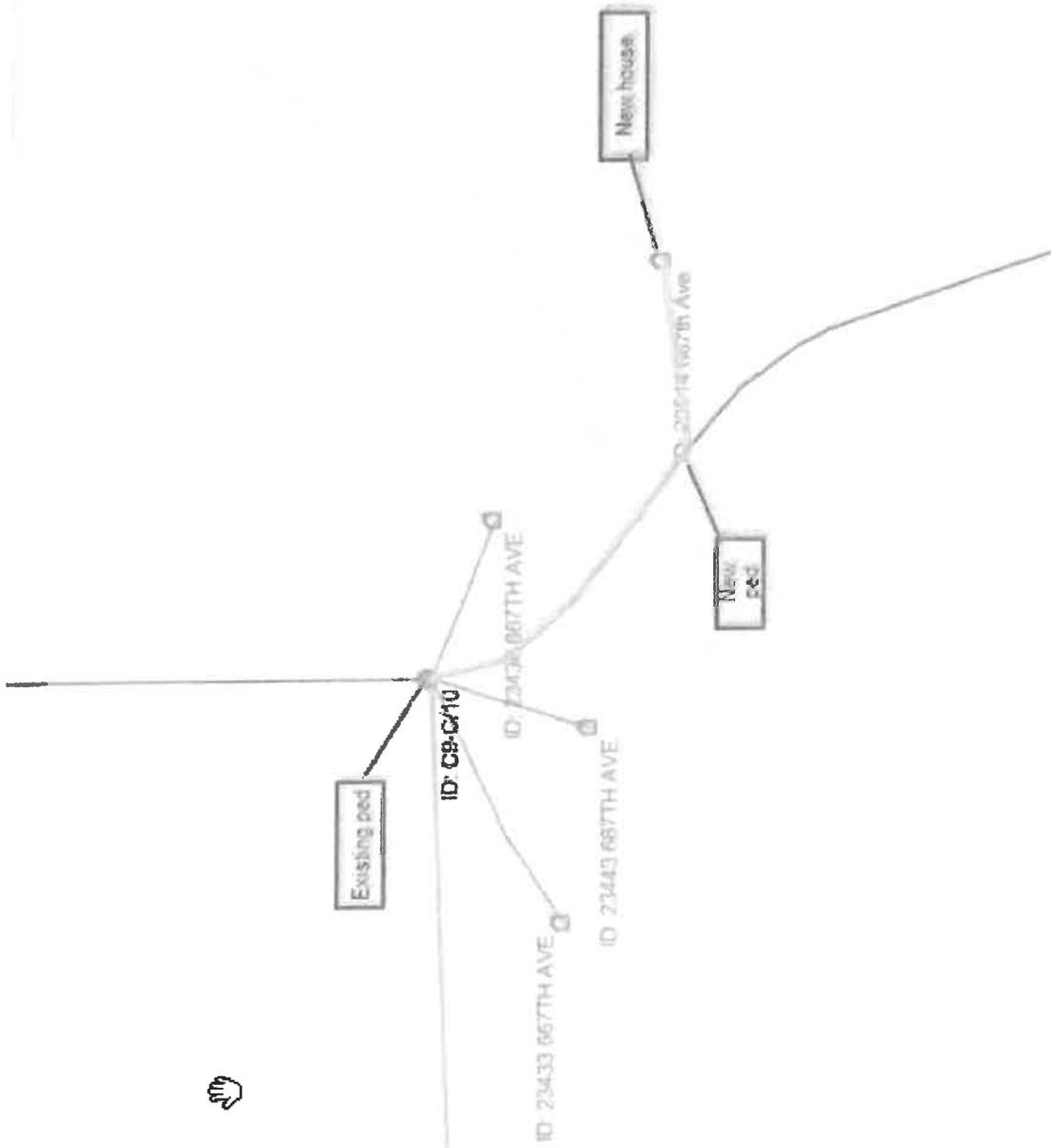

The Permittee shall be responsible for any damage resulting to said highways because of the construction operation, or maintenance of said utility, and shall reimburse Story County for any expenditure the County may have to make on said highways because of said permittee's utility having been constructed, operated, and maintained thereon.
8. The Permittee shall indemnify and save harmless Story County from any and all causes of

action, suits at law or in equity, or losses, damages, claims, or demands, and from any and all liability and expense of whatsoever nature for, on account of or due to the acts or omissions of said Permittee's officers, members, agents, representatives, contractors, employees or assigns arising out of or in connection with its (or their) use or occupancy of the public highway under this permit.

9. Noncompliance with any of the terms of permit, or agreement, may be considered cause for shut down of utility construction operations, or revocation of the permit.

10. The following special requirements, if applicable, shall apply to this permit:

Whenever the route of the proposed cable line runs along a paved secondary highway, the location of said cable shall be constructed on top of the road shoulder so as to be within approximately two-feet of the pavement edge.

Whenever the route of the proposed cable line runs along a dirt or gravel surfaced highway, the location of said cable shall be constructed on top of the road surface and as near possible to the shoulder line

Whenever a cross road culvert or bridge is encountered along the route of the proposed cable lines, said cable shall be constructed around the ends of said cross road culvert or bridge even though this looping is not designated on the situation plans attached hereto.

The crossing of the cable line from one side of the highway to the other shall be accomplished at a near right angle rather than diagonally so as to disturb the roadbed of the traveled way as little as possible.

Whenever the route of the proposed cable line is to cross a paved highway, such crossing shall be in a bored hole rather than open cut trench.

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Story County, Iowa, as follows:

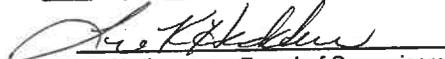

**1) Identification of Projects.** By virtue of this amendment, the list of authorized urban renewal projects in the Plan is hereby amended to include the following project description:

**Name of Project:** LMI Housing Support Program

**Date of Board Approval of Project:** November 18, 2025

**Description of the Program:** The County acknowledges the importance of the availability of safe and affordable housing to families of low and moderate income to the promotion of economic development in the County. Under the LMI Housing Support Program, the Story County Housing Trust (the “Housing Trust”) will provide economic development forgivable loans and/or grants to cities with qualifying projects for the redevelopment, rehabilitation and development of housing that is affordable to families of low and moderate income.

**Description of Use of TIF:** The County intends to enter into an economic development support agreement with the Housing Trust with respect to the administration of the LMI Housing Support Program and to provide annual appropriation economic development payments (the “Payments”) to the Housing Trust in support thereof. The Payments will be funded with incremental property tax revenues to be derived from the Urban Renewal Area. It is anticipated that the County’s total commitment of incremental property tax revenues with respect to the LMI Housing Support Program will not exceed \$2,000,000.

**2) Required Financial Information.** The following information is provided in accordance with the requirements of Section 403.17 of the Code of Iowa:

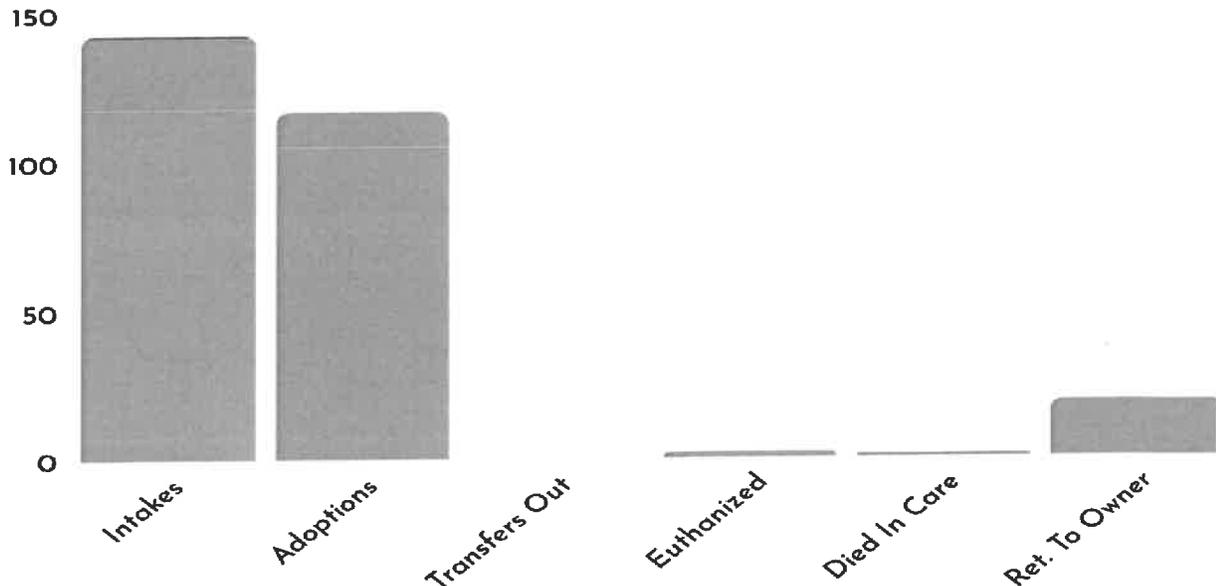

## Quarterly Report Summary

### Animal Intake & Adoptions

As is typical for this time of year, intakes increased. Between July and September, the shelter took in 118 cats, 24 dogs, and 1 pet rat. Adoptions nearly doubled compared to last quarter, with 105 cat adoptions and 12 dog adoptions.

### Animal Control

Animal control calls also increased, reflecting seasonal trends. We responded to numerous stray animal pickups, complaint investigations, welfare checks, and bite case investigations throughout the quarter.

### Events

On September 20, we partnered with the Camelot Theater Foundation to host the Cat Video Fest, a day filled with cat videos, adoptable cats, and community fun. The event also included a pet supply drive, which brought in much-needed donations for the animals in our care.

### Social Media & Outreach

We continued expanding our social media reach by sharing numerous Story County Animal Shelter alumni success stories and highlighting our adoptable pets. Posts featuring new intakes have also helped reunite lost animals with their owners and raise awareness of shelter services.

### Recognition

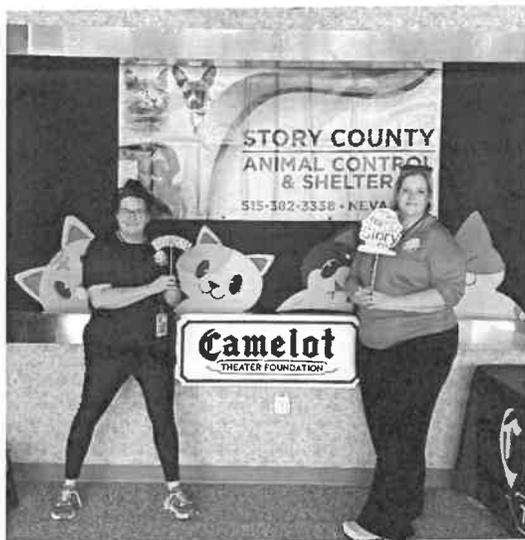
We received recognition from Best Friends Network for maintaining our No-Kill designation. A 90% or higher save rate is the nationally recognized benchmark for being considered No-Kill, acknowledging that approximately 10% of shelter intakes may require humane euthanasia for severe medical or behavioral reasons. Never for space or length of stay. Story County has proudly operated as a No-Kill community for many years, well before this national recognition.

### Volunteers

We continue to benefit from several dedicated volunteers, including a few who specialize in dog training and enrichment. Their ongoing work provides critical support and helps long-term dogs improve their behavior and adoptability.

### Community Services

Although held just after the reporting period, I wanted to briefly highlight our Free Vaccine and Microchip Clinic held on October 11. This event was made possible through donated vaccines from Petco Love, support from community donors, and assistance from the Shelter Medicine Club at Iowa State University College of Veterinary Medicine. More than 80 animals received wellness exams, vaccines, and microchips. More detailed figures are to be shared in the next quarterly report once all records are finalized.
