

The Board of Supervisors met on 3/9/21 at 9:00 a.m. in the Story County Administration as the Board of Canvassers to canvass the results of the March 2, 2021 United Community School District Special Election. Members present: Lisa Heddens, Latifah Faisal, and Linda Murken, with Heddens presiding. (all audio of meetings available at storycountyiowa.gov)

Lucy Martin, Auditor, reported most of the school district is in Boone County; Story County's certified results will be included in the second-tier canvass held by Boone County next week. Martin thanked her staff and election workers. Kevin Norris, Deputy Auditor, reported there are 450 registered voters in United CSD in Story County; seven (7) voters participated in the election. Martin reported no absentee ballots or provisional ballots were cast.

Faisal moved, Murken seconded the approval of Resolution #21-74, certifying the results of the election. Motion carried unanimously (MCU) on a roll call vote.

Murken moved, Faisal seconded to declare the canvass complete and to certify the results of the election to the appropriate jurisdiction (on file in the Auditor's Office). Roll call vote. (MCU)

Faisal moved, Murken seconded to adjourn at 9:05 a.m. (MCU)


