

DRAINAGE MEETING
JOINT DRAINAGE DISTRICT MARSHALL-STORY #3
MAY 28, 2021

The Drainage District Trustees of Marshall and Story Counties met in a Zoom videoconference originating from the Grand Courtroom of the Marshall County Courthouse in Marshalltown, IA to consider a levy for repairs (see attached levy sheet) against Joint Drainage District Marshall-Story #3, Marshall County controlling. Members present were Dave Thompson, chair, Bill Patten, and Steve Salasek of Marshall County and Lisa Heddens and Latifah Faisal of Story County. Also present were State Center Fire Chief Brad Pfantz, Marshall County Drainage Clerk Whitney Hunt, and Story County Drainage Clerk Scott Wall.

Thompson called the meeting to order at 3:02 p.m.

Patten moved, seconded by Heddens, to approve the agenda. Motion carried unanimously (MCU).

Thompson said this meeting was needed to levy Joint Drainage District Marshall-Story #3 for the cost of a tile repair done by Ricken Tiling, payment of which was approved at a meeting on March 16, 2021.

Patten moved, seconded by Salasek, to accept the recommendation of the drainage clerks to levy Marshall-Story #3 with assessments to be due and payable on or before September 30, 2021.

Thompson asked for any background information or discussion on the proposed levy.

Hunt said the district needed to be levied at 37% to pay for the work done by Ricken Tiling and leave some money for future repairs.

Wall elaborated that the district had insufficient funds to cover the repair by Ricken tiling and the 37% levy would generate funds sufficient to cover the deficit plus leave approximately \$5,000 in the district fund. For a district of this size, with an original assessed value of about \$61,000, the drainage clerks believe that a \$5,000 carryover is not excessive.

MCU by roll call vote with Trustee Linda Murken absent.

There being no further business before the trustees Thompson adjourned the meeting at 3:09 p.m.
