

The Board of Supervisors met on 9/20/22, at 9:00 a.m. in the Board Room at the Story County Administration as the Board of Canvassers for the Special Elections for the cities of Slater and Story City held on 9/13/22. Present were Latifah Faisal, Linda Murken, and Lisa Heddens, with Chairperson Faisal presiding.

Lucy Martin, Auditor, reported on the two elections held on 9/13/22: Slater considered a general obligation bond and Story City had two public measures. Martin reported the Des Moines Register/Ames Tribune article about the election erroneously stated Slater had passed its measure. The Slater bond did receive 52% 'Yes' votes but it needed 60% to pass. The paper did correct the error. Both measures in Story City were successful. Martin thanked her staff and the poll workers. Kevin Norris, Deputy Auditor, reported no provisional ballots were cast.

Heddens moved, Murken seconded the approval of Resolution #23-23. Motion carried unanimously (MCU) on a roll call vote. Murken moved, Heddens seconded to declare the canvass complete and certify the results of the election to the appropriate jurisdiction. Roll call vote. (MCU). Heddens thanked the Auditor and Norris. Heddens moved, Murken seconded to adjourn at 9:03 a.m. Martin added today 9/20/22 is National Voter Registration Day.




