Narrative

Vehicle #1 was north bound on 630th Avenue approaching the drive of 19986 630th Avenue. On the west side of the road was a truck and trailer and on the east side of the road was an excavator. The victim was working on the back end of the trailer, attempting to lock the ramps so the excavator could be loaded onto the trailer. Vehicle #1 drove northbound, between the truck/trailer and the excavator, striking the knee of the victim with the back driver side quarter panel of the pickup.

Witnesses at the scene heard the yelling and came to the scene. Witnesses stated a county truck was coming down the roadway, so they had the county workers follow vehicle #1 and get the plate information.

Reporting deputy met the driver of vehicle #1 at a business located at 650th Avenue and 210th street. Driver of vehicle #1 was identified as Kenneth Frey. Frey was not impaired and advised that he had no idea that he had struck an individual. Frey stated his window was up, however, he thought he heard yelling, so he stopped. The driver of vehicle #1 did not see anyone, so he continued north bound. Frey and this deputy returned to the scene of the accident.

Already present at the scene and getting voluntary statements was Sgt. Randy Mortvedt. Deputy Jason Grubbs who also responded to the scene, was in route to MGMC to meet with the victim.

This deputy took a written statement from Frey. This deputy also spoke with the county workers who had followed vehicle #1. They advised that the driver was only going approximately 30 mph and did not seem to be trying to "get away" from the scene.

This deputy consulted with the Story County Attorney's office reference possible charges against the driver. It was decided that no charges will be filed.

The victim was taken to Mary Greeley Medical Center with a possible knee injury.

Photos were taken at the scene by Sgt. Mortvedt. This deputy also witnessed what appeared to be where someone had brushed up against the side of the truck.
