Unit 1 was northbound on 645th Ave at approximately 40 mph when it missed the L curve in the roadway, driving into a 15 foot deep ditch, striking the far side of the ditch with the front end of the vehicle. Driver and passenger were unfamiliar with the territory and were unable to give clear directions as to where they were located at the time of the collision. Story County deputies eventually located them. No current insurance was located on the vehicle and the driver was in such a state at time of investigation that he was unable to provide a phone number. Both driver and passenger were transported to Des Moines
