BOARD PROCEEDINGS

10/26/10

The Board of Supervisors met on 10/26/10 at 9:30 a.m. in the Story County Administration Building. Wayne E. Clinton, Jane E. Halliburton, Rick Sanders, and with Chair Wayne E. Clinton presiding. Sanders moved, Halliburton seconded to approve the consent agenda as follows:

Utility permit #11-30 for Interstate Light & Power Co. is requesting permission to occupy certain portions of public right-of-way to establish the location of electric energy, approx. 1 mile W. 4th N. Ave to X Ave.

FIRST CONSIDERATION OF ORDINANCE #205, exempting certain land used primarily as training grounds for Peace Officers from enforcement of the Story County Land Development Regulations and permit Sheriff to control and regulate activity on described land - Sheriff Fitzgerald reported his department currently has 4 days for training, and he is would like to be able to train 7 days per week. He has worked with the Attorney & P&Z Office. Clinton asked about protocol for the use of the range. Fitzgerald responded with pre-established hours. Lt. Ellis reported on the range rules/regulations and schedules. Clinton stated the Board of Adjustment guidelines would have to change. Clinton noted there was communication from Knapp Tedesco Insurance in 2009 regarding signs and things to help with safety in warning the public. Fitzgerald stated all have been implemented. Discussion took place. Steve Owen, Assistant County Attorney, reported that the structure of control would not change. The Board would maintain ultimate control of the property; the Sheriff would have management control. Clinton opened the public hearing @ 10:10 a.m. Marty Chitty, 60831 – 210th St., Nevada listed concerns if this takes place. As a nearby property owner, he feels disenfranchised, and would like P&Z's opinion. Lloyd Brown, 61192-210th St., Nevada reported there are 6-7 families around this range. H doesn't want it to be used 24-7; the Board of Adjustment has voted down the request from the Sheriff & of other entities to use this. Brian Anderson, Representative of Knapp Tedesco & ICAP, reported on the ICAP liability report from a safety stand point and recommended the Board approve. Paul Toot, 23433-667th Ave., Nevada, asked about what ordinance and restrictions would cover the range. Hearing no further comments, Clinton closed the public hearing @ 10:26 a.m. Further discussion took place between the Board, the Sheriff, and Leanne Harter, the P&Z Director. Recess @ 10:50 a.m., reconvene @ 10:57 a.m. Halliburton moved, Sanders seconded to defer back to Staff. Additional discussion included the procedural purpose of the flood plain, the process to divide this parcel, the Board of Adjustment opinion, and concerns of area residents. Sanders asked to amend the motion. Owen stated to finalize Halliburton's motion and then make a second motion. Clinton called the question. Roll call vote. (MCU). Sanders moved, Clinton seconded to defer back to Staff and to set a date for a public hearing on Tuesday, November 9th, 2010 @ 6:00 p.m. at the Administration Building and to notify all property owners within 1/4 mile of the range by phone or mail, and for the P&Z Department to provide a list of property owners and the Board will contact. Clinton stated to check the schedule for an evening meeting. Sanders removed the specific date of November 9th. Clinton called the question. Roll call vote. (MCU).

PRESENTATION OF VETERANS AFFAIRS FOSTER HOME PROGRAM – Brett Mclain, Director, provided background info, and introduced Jan O'Briant & Scott Olson. Jan O'Braint is from the VA Medical Center in Des Moines. The 1st medical foster homes in Story County were established this year. This houses veterans who can't live on their own and have no family members. They pay their own way. The program allows 3 veterans per home; 8 homes and 10 veterans living in the homes. Scott Olson reported on WWII Veterans, and his program of building small airplanes & sell to American Legions.

ACKNOWLEDGE EXCHANGE AND RECEIPT OF UNION CONTRACT PROPOSAL BETWEEN STORY COUNTY (AS EMPLOYER) AND PPME LOCAL 2003 (AS BARGAINING UNIT REPRESENTATIVE) FOR STORY COUNTY SHERIFF'S OFFICE AND STORY COUNTY SECONDARY ROADS EMPLOYEES – Steve Owen, Assistant Attorney, introduced Lacey Galetich to exchange the proposal between employer & employee representative for the Sheriff's Office and Secondary Roads. Owen has received the proposal from the stated bargaining units and and is asking for a motion from the Board to acknowledge receipt of that proposal. Halliburton moved, Sanders seconded the acknowledge receipt of that proposal from the Sheriff's Union rank & file. Roll call vote. (MCU). AGREEMENT WITH CGI COMMUNICATIONS TO PROMOTE STORY COUNTY – Supervisor Clinton reported on a teleconference supported by CGI Communications. He has passed the proposal to the Attorney's Office, I.T. Department, and Board members. This agreement would allow access to a website that Story County would not own, and it would be no cost to Story County. It would allow advertisements to local businesses.. Sanders stated he is in support for having video to promote the County, but is concerned about soliciting businesses. He would like to explore the cost for Story County to do their own for comparison. Halliburton moved, Sanders seconded to deny the invitation. Halliburton stated to explore the value for the future. Matt Riese, IT, commented that based on the samples from Boone County, if that we would move forward we would incorporate it. It is coming from CFI Co and could include notification that it is not from Story County. Clinton called the question. Halliburton aye, Sanders aye, Clinton aye.
